

## HSB 698 would take SNAP away from parents, increase children's risk of food insecurity and make it difficult for struggling families to learn, work and thrive

SNAP, called Food Assistance in Iowa, helps people put food on the table and get back on their feet after tough times. SNAP provides nutrition assistance to eligible individuals and household based on their household size and income.

SNAP plays a central role in fighting hunger when need is great. In fall 2021, 26% of Iowa households with children reported that the children sometimes or often were not eating enough because the household could not afford enough food.<sup>1</sup>

**There is little evidence requiring custodial parents to cooperate with child support recovery yields extra income for children — even as it puts their nutrition at risk.**

HSB 698 would require custodial parents to cooperate with child support recovery. This provision would threaten child food security without increasing child support payments. Here are the problems:

- **Taking SNAP benefits away from parents puts children at increased risk of food insecurity.** When parents lose food assistance for non-cooperation, both parents and children stand to get hurt. If a custodial parent is subject to a mandate and fails to cooperate, sanctioning their SNAP benefits reduces the family's overall food budget and puts children at increased risk of food insecurity and inadequate nutrition.
- **Child support cooperation requirements threaten the safety and well-being of children.** There are many reasons why parents and guardians do not open formal support cases through the Child Support program, including personal safety, and the policy could put families who have experienced domestic violence at risk.
- **There is little evidence to suggest the policy would work.** In places where similar requirements have been studied, they've yielded a negligible amount of extra income for families despite significant implementation costs. For example, North Carolina, which implemented a similar pilot program mandating that families who receive child care assistance cooperate with child support recovery, found it to be highly inefficient. It cost \$2 million to implement, but only led to a total of about \$7,000 in child support payments to 12 families over a year, or only about \$50 a month.<sup>2</sup>
